1. Call to Order, Roll Call at 4:15pm

b. Threats, Hazard, and Mitigations-Directors Sealey, Kerrin and Chief Morrison Purpose: To develop the Threat and Hazard Identification and Risk Assessment (THIRA), develop the Stakeholder Preparedness Review (SPR), update the Community Wildfire Protection Plan (CWPP), and develop the Deer Springs Annex to the San Diego County Multi-Jurisdictional Hazard Mitigation Plan (MJHMP)

The committee held a meeting prior to todays' board meeting. FEMA approved and issued a Hazard Mitigation Grant Program (HMGP) funds to hire a contractor to assist and coordinate in the development of the next five year update to San Diego County Multijurisdictional hazard Mitigation Plan (MJHMP) which expires in 2028. Each participating agency is eligible to receive contractor assistance which includes Deer Springs Fire MJHMP Annex.

11. New Business

a. Station 2 Special Inspections and Testing. As presented at the February 14, 2024 and June 12, 2024, meetings, the District will provide Self Certification of Station 2 construction activities located at 1321 Deer Springs Rd, San Marcos, CA 92069. To ensure compliance with the San Diego County Building Code and other Regulations, the District requires selection of appropriate independent engineering services to validate the work on behalf of the District. Government Code §37103 provides for the contracting with any specialty trained and experienced person, firm, or corporation for special services and advice in engineering matters. On behalf of the District, EC Constructors, Inc. has solicited Requests for Proposal to six qualified companies. EC Constructors will present their evaluation of the received proposals.

Action requested: Receive the EC Constructors proposal evaluation, select the proposal that offers the best value to the District, and authorize the Board President to enter into a contract with the selected company to provide the Special Inspections and Testing

Director Sealey made a motion to authorize EC Constructors to contract directly with Christian Wheeler for Geotechnical Observations & Soil Testing and utilize Nova Services for Special Inspection and Material Testing; to manage that scope of work and bill Deer Springs as pass through over the fixed contract cost with copies of all test reports and monthly reporting of costs for total cost not to exceed \$85,000 to be managed by EC Constructors; Director Holley seconded the motion. Motion is adopted; 3 Ayes; 0 Noes; 2 Absent (Jackson & Gordon); 0 Abstain

b. <u>August Regular Board Meeting.</u> The Clerk of the Board has a schedule conflict and will neither be able to prepare for nor attend the meeting as scheduled on August 14. Pursuant to the Bylaws Article IV, Section 1, the meeting date, time, and location may be changed from time to time by majority vote as dictated by changing circumstances.
